\*Every applicant who is not a resident of Marathon County or who represents a firm whose principal place of business is located outside of the state shall file a surety bond in the amount of \$500, approved by the Village Administrator, conditioned that the applicant will comply with all provisions of the ordinances of the Village and the state laws regulating peddlers, canvassers, solicitors, and transient merchants and guaranteeing to any person doing business with the licensee that all money paid as a down payment will be accounted for and applied according to the representations of the licensee and further guaranteeing that property purchased for future delivery will be delivered according to the representations of the licensee. Action on such bond may be brought by any person aggrieved. The amount of the bond made under this section will be refunded 30 days after expiration of the permit or 30 days after the voluntary surrender of the permit.
